Captain Couch (HoundDog 51) and Captain Frederick (HoundDog 51) were flying a visual reconnaissance mission on the above date. Hillsburro, the airborne control informed Hound Dogs 51 and 53 that he had received a transmission to the effect, "May Day, May Day, Hillsburro, Spud 5,6" at 1648 hours. Since there was no other FAC's in area Hound Dogs 51 and 52 headed simultaneously to two separate coordinates known to have anti-aircraft guns in place that day and ask Hillsburro to go to TGT 502 C, another "Hot" spot.

Captain Couch had seen the two Spud aircraft approximately twenty minutes before the emergency transmission. Hillsburro reported hearing a signal from the pilot emergency radio.

Hound Dogs 51 and 53 rushed to area and began search. Hound Dog 51 was first to arrive, heard signals from two radios and located both crash sites and obtained visual contact with both Spud crews, two men in each crew. At approximately 1730. Hound Dog 51 talked to both crews and was told by the crews that they were ok. Hound Dog 51 gave each crew a landmark to be at for pick-up by rescue in case communications were loct. Soon after this Hound Dog 51's radio went out on UHF and could not talk further to the crews. Hound Dog 53 took over and talked to the crews telling them to "Hold on, rescue is on the way".

Spud 6 reported the V.C. were closing in on them and his radio become weaker and broken and quit at approximately 1815. Hound Dog 51 flew continually at tree top level around the crows, located enemy fire and marked for Hound Dog 53 the directed suppressive fire. Hound Dog 53 directed the rescue of Joud 5 at 1850 hours and to the site where Spud 6 was last seen. Ground fire was received from all directions around his position.

At 1920 Hound Dogs 51 and 52 had to leave area due to critical fuel shortage.
